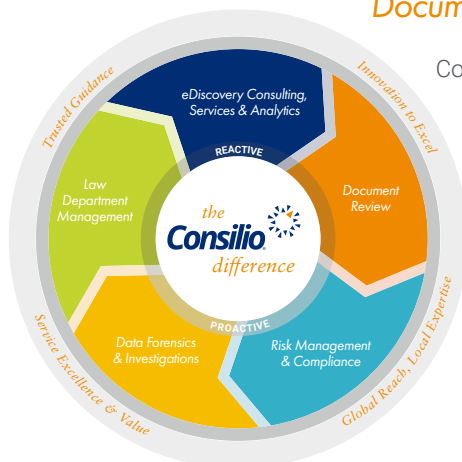
## Consilio Response

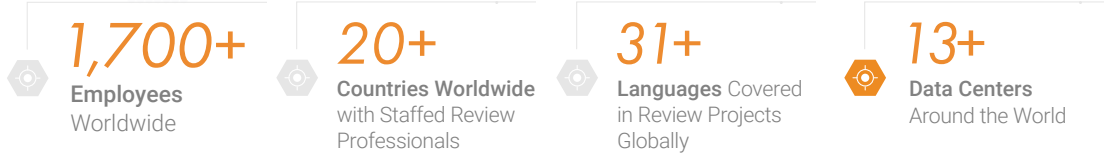
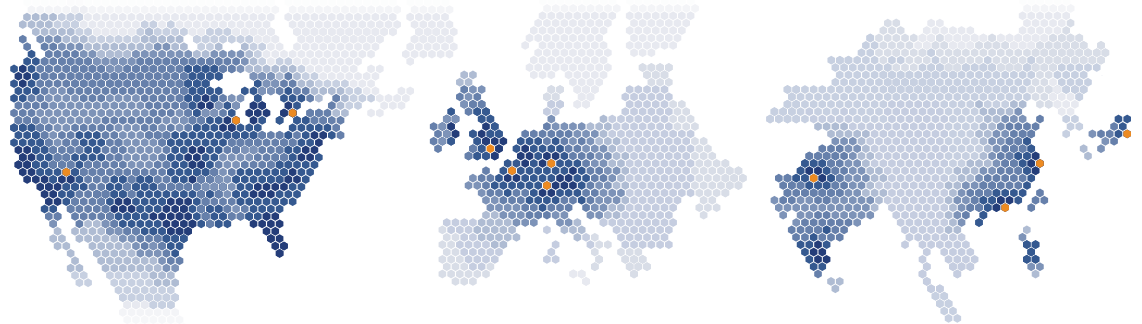
